

## Evangel Christian School K4 Tuition and Fees for 2024-2025

K4 students must be 4 years old by **September 30, 2024** and be **toilet trained**.

### Registration Fees:

New students must apply to be considered for enrollment. The application fee is \$30. The instructions on how to apply can be found here: [Instructions to Apply](#) or on our website at [www.ecsdalecity.org](http://www.ecsdalecity.org).

**Registration Fees must be paid in full to hold a space for your child. These fees are non-refundable unless a family moves more than 25 miles from the school **prior** to the first day of school.** The registration fee covers the costs involved in registration and enrollment.

**Reenrollment Registration:** The registration fee for each student is: **\$100 February 1-29<sup>th</sup>**.  
(returning ECS families)

**Open Enrollment Registration** The registration fee for each student March 1<sup>st</sup>-July 31<sup>st</sup> is: **\$150.00**, and beginning August 1 is: **\$200**.

### Material and Activity Fee (MA Fee): \$475.

***The MA Fee is due on July 1st of each year and is non-refundable.***

This fee covers the curriculum, classroom supplies, and art supplies. ***After July 1<sup>st</sup>, a student may lose their position in the class if this fee is not paid.*** Students enrolling after July 1st must pay the registration and MA fee when they submit their enrollment paperwork. This fee is Non-Refundable.

### FACTS Tuition Management:

**FACTS** is an online tuition payment system that is used for withdrawing tuition directly from your bank account on the 5th of each month. All families must enroll in the FACTS program for tuition payments. The Evangel Business Office can assist in the enrollment process. Tuition does not cover incidental expenses such as field trips. **\*Credit card payments will be charged a fee of 2.85%\***

### FACTS offers a 12 month (July-June) or 10-month payment plan (August-May).

All 12-month families must be enrolled in FACTS by June 18<sup>th</sup>.

### Discounts:

A 3% discount will be given for yearly tuition paid in full before August 1<sup>st</sup>. All fees must be paid in full, to qualify for the discount.

**There are NO multiple child discounts for K4 tuition due to limited space and the costs incurred to provide a program of this nature.**

### School Student Referral Program (PSST):

Any parent referring a new student to the school prior to their first interview will receive a tuition discount of 3% of the new students' tuition fee. Forms and information on how the PSST program works are available in the school office. Forms must be completed to receive discount. Referrals are paid out February 1<sup>st</sup> of the following year.

**Withdrawals:** Students that withdraw are required to give two weeks' notice in writing. If not, an additional two weeks tuition will be charged to that family's account. A \$75 withdrawal/dismissal processing fee will apply for withdrawn or dismissed students. Tuition for that student is calculated at a daily rate multiplied by the number of days attended. Any tuition that was paid in advance will be refunded within a month of withdrawal. If balances are not paid, transcripts/report cards will be held until balances are paid in full.

**Extended Daycare (EDC)**

All Families requiring Extended Care during the school year **MUST COMPLETE AND UPLOAD** the **Extended Care Form** found on the **Instructions and Resources** page of the enrollment packet to be eligible for Extended Care. Parents must also select Before Care, After Care, Both Before and After Care, or Hourly Care at the bottom of the **Enrollee Information** page of the enrollment packet. Plans selected may be changed, if needed, with appropriate notification to the school office and Extended Care.

This service is offered on a first-come-first-served basis, depending on space and/or supervision available.

**Full-Time Extended Daycare:**

Families requiring Extended Care should sign up when enrolling. Families are given the option to sign up for a Full-Time monthly plan or to be charged an hourly rate, as needed. In general, if a student is using more than 5 hours per week in EDC, they should enroll in a Full-Time monthly plan. *The cost of the program is divided into 10 monthly payments (August – May).* Additional fees will be incurred if students are not picked up on or before 6pm.

**Hourly Extended Daycare:**

Students may use hourly EDC as long as they are enrolled in EDC during the registration process. Hourly EDC is invoiced monthly, then added to the parents FACTS account. **All children not enrolled in EDC who are here beyond their scheduled leave times will be charged for hourly EDC.**

Children not picked up by 6:00 PM will be charged a rate of \$16.00 *per 15 minutes* or part thereof. That rate will increase to \$20.00 after 7 PM.

- ***Extended Care follows the school schedule, beginning the first day of school and ending on the last day of school. Extended Care is not available on school observed holidays or breaks and PM Care is not available on half-days when the school closes at Noon.***
